Due to new state Regulations we have made the following changes:

- 1. In an effort to cut down on the spread of COVID-19, parents are no longer allowed to enter our facility.
- 2. When you arrive at our facility you will park in the regular designated areas as before. Please bring your child to the main entrance to the building or the classroom door of the Modular building. A Staff member will greet you OUTSIDE wearing gloves and a mask. We have been advised to take the temperature of each child before they enter the building. Any child with temperature of 100.4 will not be allowed to enter the facility. You will also be asked several questions that pertain to whether you or any household member has been tested or been exposed to someone with COVID-19.
- .3. At the END OF THE DAY, depending on where your child's classroom is you are asked to do the following:
- a) DOWNSTAIRS Classrooms Please come to the main entrance, ring the buzzer and a staff member will greet you outside with your child.
- b) UPSTAIRS Classrooms Park your car and come up the ramp to your child's classroom. A staff member will greet you when they hear you knock and you will be asked to wait outside while they get the child ready to return to you.
- c) MODULAR Classrooms When a staff member hears your knock they will greet you outside with your child.
- 3. We ask you to please bring any supplies in a plastic zip lock bag. These can be found in 2 gallon size if needed. We will launder any blankets each week or sooner if needed. Do not bring any blankets or belongings that need to come back and forth from your home each day.
- 4. Children will be monitored regularly throughout the day. Any parents of children showing symptoms of COVID-19 will be called and asked to pick up their child immediately. Symptoms such as Cough, Shortness of breath or difficulty breathing, Fever of 100.4, chills, loss of taste or smell, vomiting or diarrhea. We strongly advise you to Not give your child any fever reducing medicine before their arrival. Staff cannot determine if a fever is related to teething, ear infections or anything not contagious. Therefore, children must be asked to leave and return only with a doctor's note.
- 5. We will have limited designated rooms for children to be cared for during the day. Each of these areas will have a designated floater that will take children to and from their parents. This person will also do the breaks and lunches for these teachers. We want to keep the same staff members working in the same areas as much as possible.
- 6. We will be serving all meals in the classrooms for all ages.
- 7. Each classroom will follow sanitizing guidelines set out by the health department for cleaning and sanitizing all toys and surfaces. All climbing equipment and toys on the playground will be sanitized each day after children leave the playground.
- 8. If there is a confirmed case of COVID-19, we will be notifying all of our families enrolled at our center. Then following the direction of our Health department we may be asked to close our center for at least 24 hours and up to 14 days depending on the circumstances. Please have a plan in place for someone to keep your children if this happens.
- 9. All staff are asked to wear a mask to protect themselves and the children. Parents can provide a mask for their child if they are over the age of two years old at their own discretion.
